2010 GOLF TOURNAMENT AT LONE WOLF GOLF COURSE

The 18-hole par 72 championship course is located at the base of North Taylor Hill. Turn North East off the HWY, turn left on spruce, and right on 99 Ave, follow to the parking lot. It is 7141 yards in length from the championship tees and contains a mix of challenging long par 5's and interesting par 3's. The immaculately conditioned course has been designed to be challenging for the expert, while enjoyable for the average and casual golfer. The length and degree of difficulty can be varied with several tees on each hole and 86 sand bunkers. Nestled in a valley, it is not uncommon for golfers to see moose, deer, eagles and elk while playing the course. In addition the course is surrounded by a 3.9 km participation trail.
