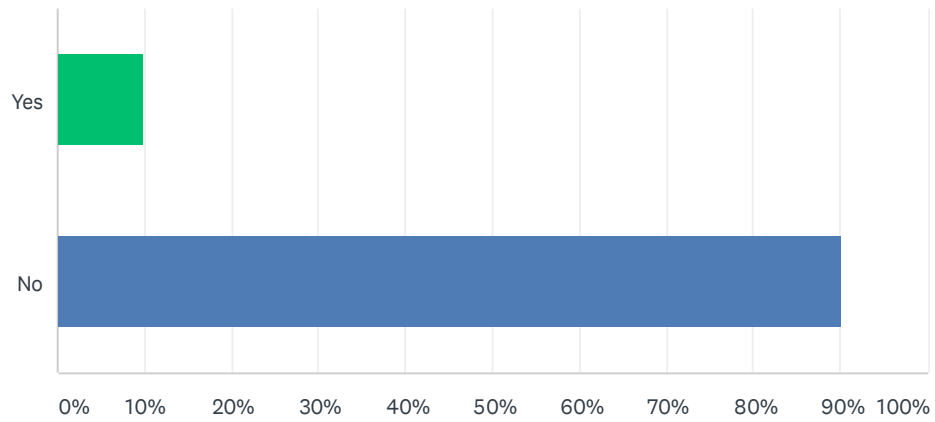


Q1 Do you support vaccine verification in order to access discretionary services?

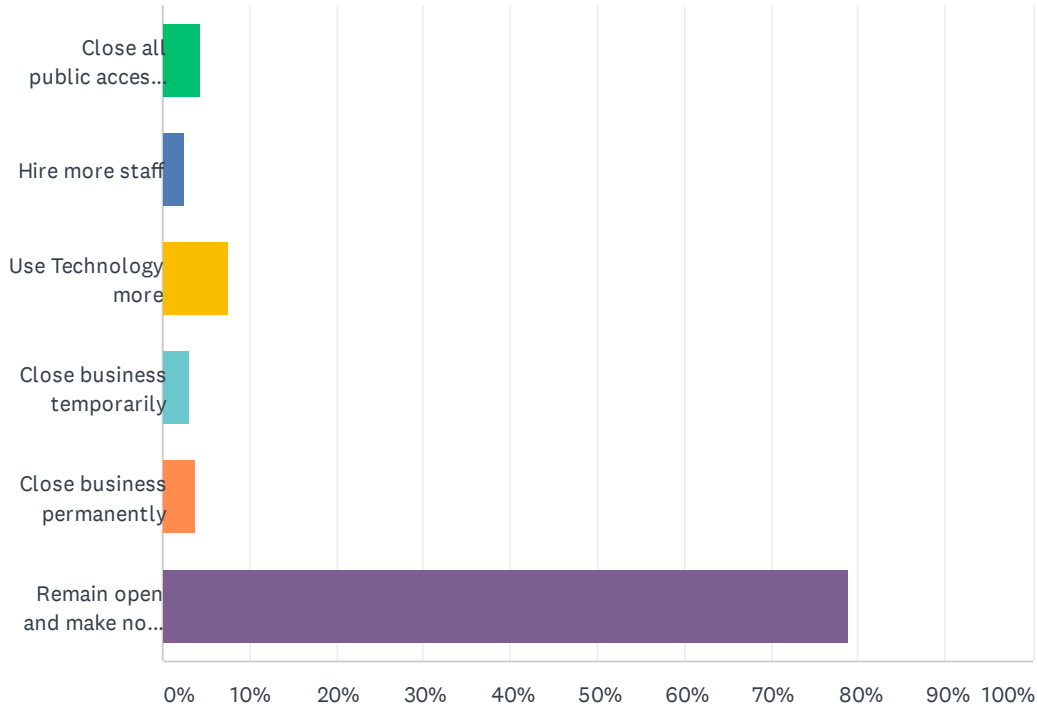

Q2 Are you considering any plans to change how you do business?

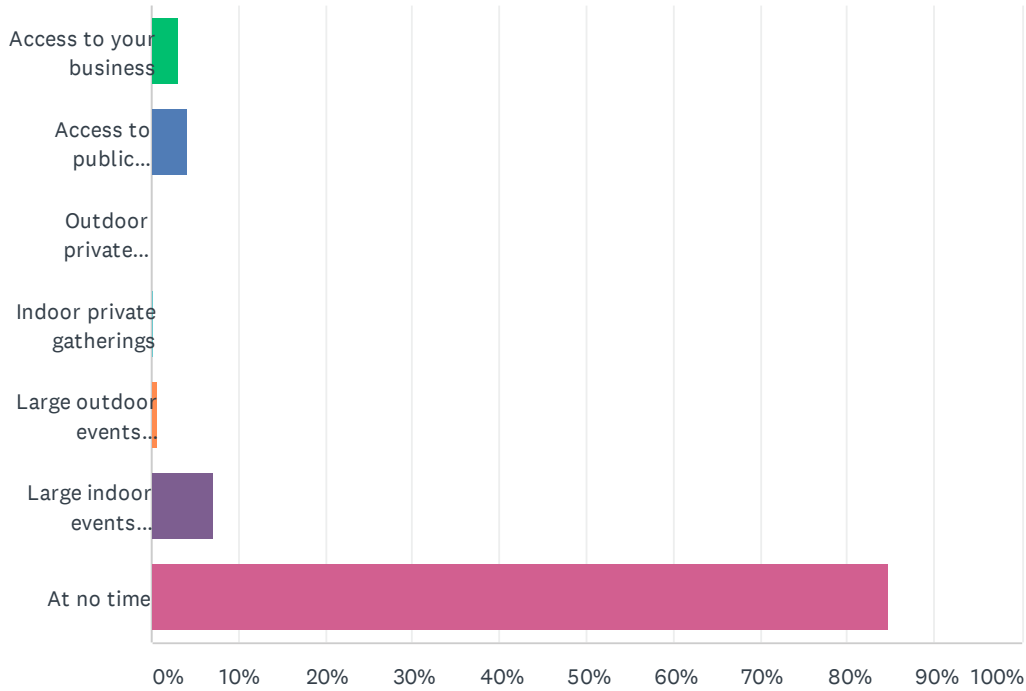

Q3 At what level of public engagement do you think vaccine verification is appropriate?

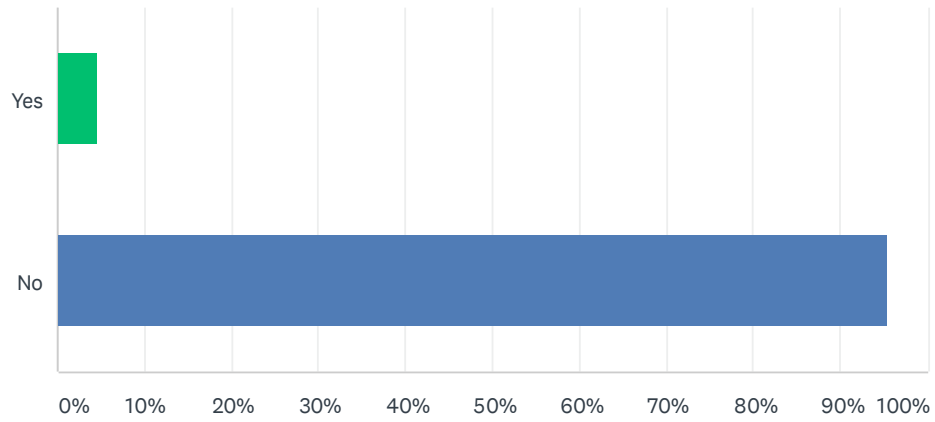

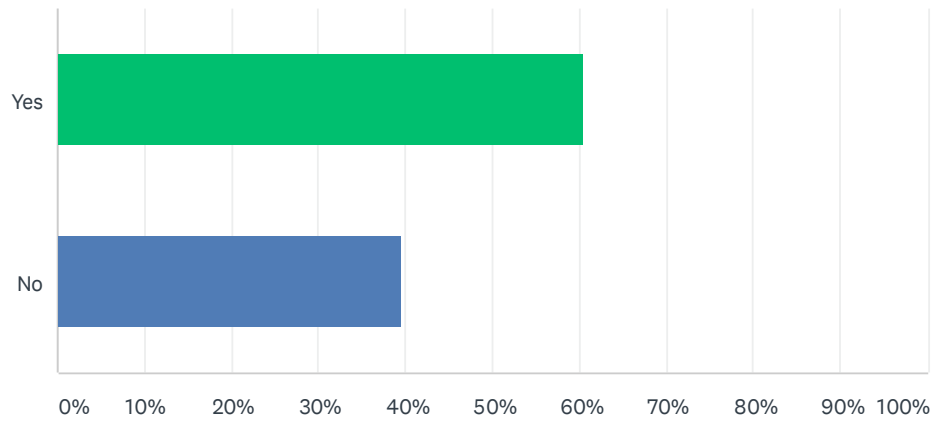

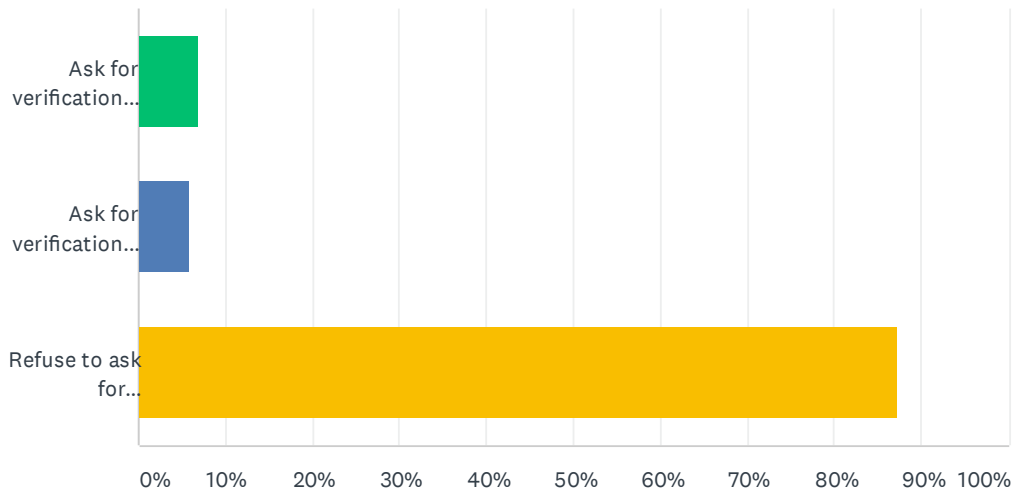

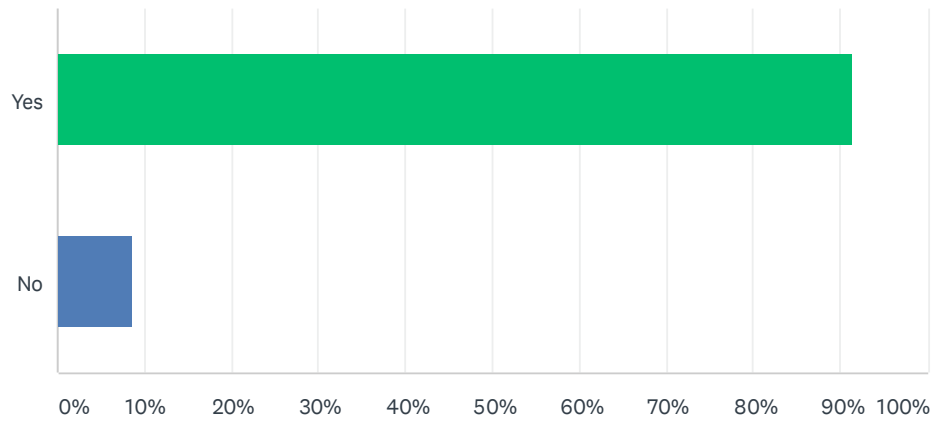

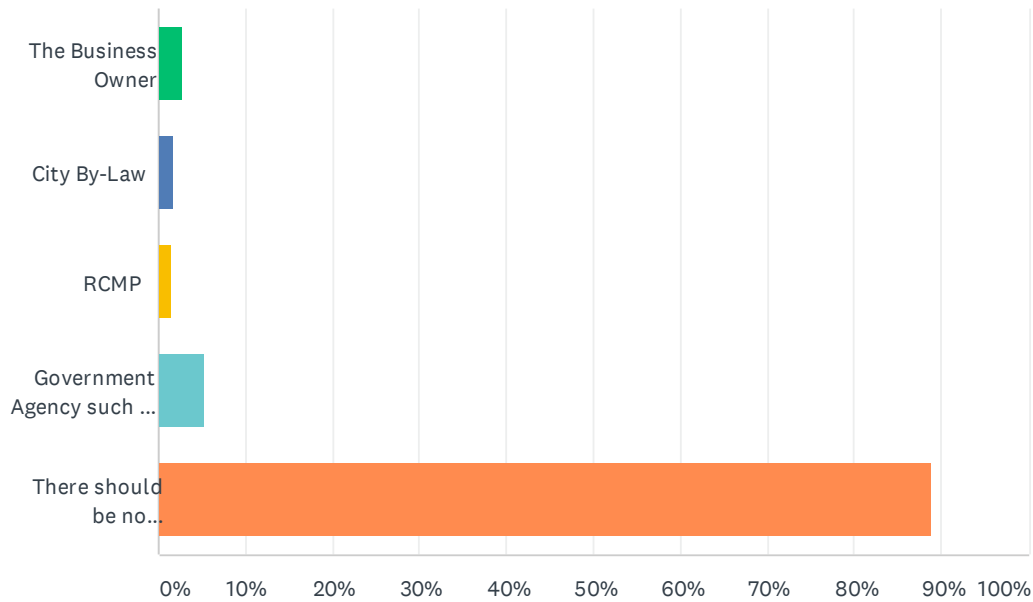

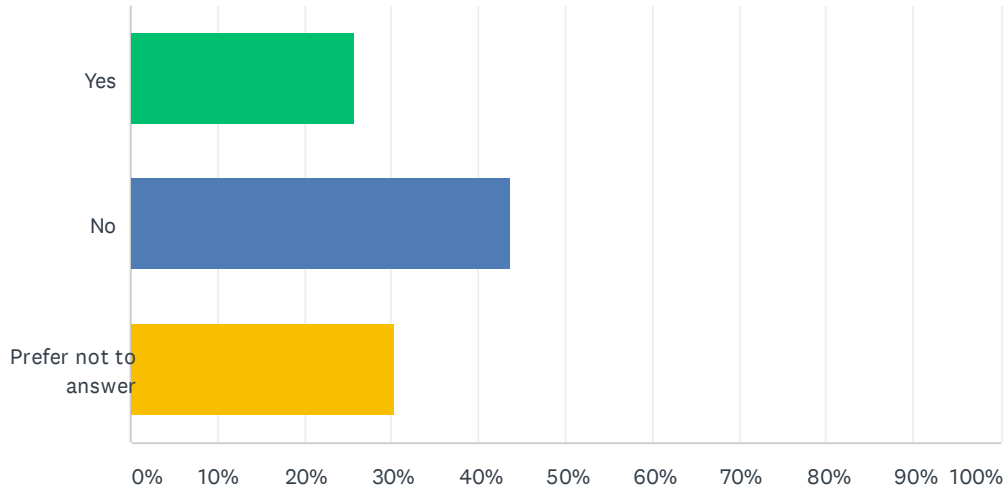

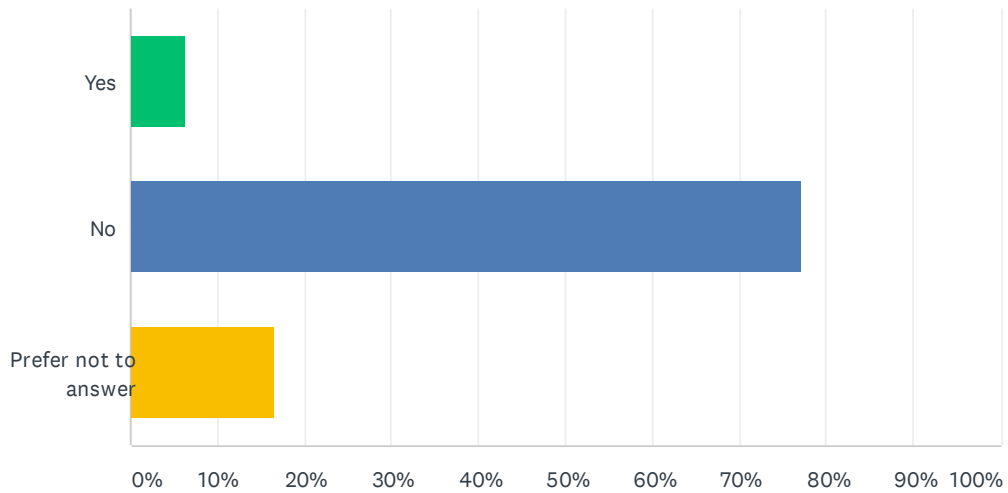

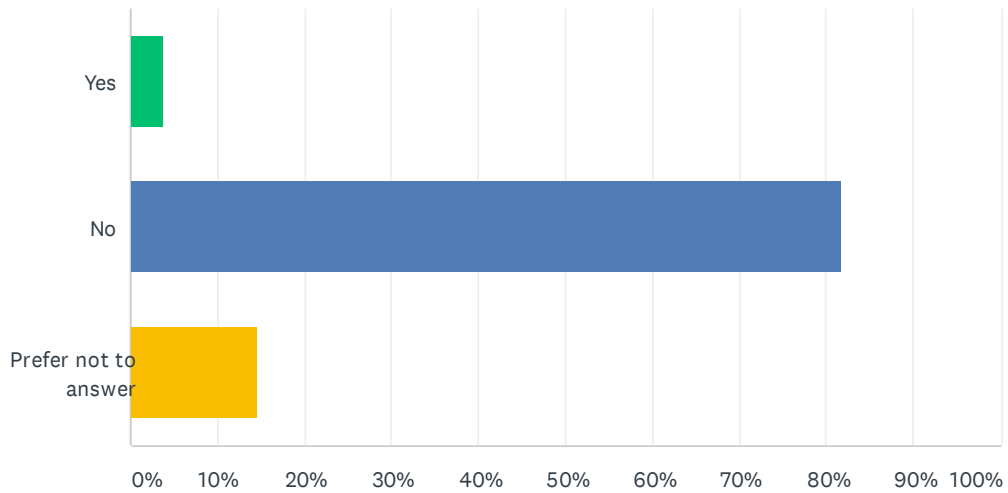

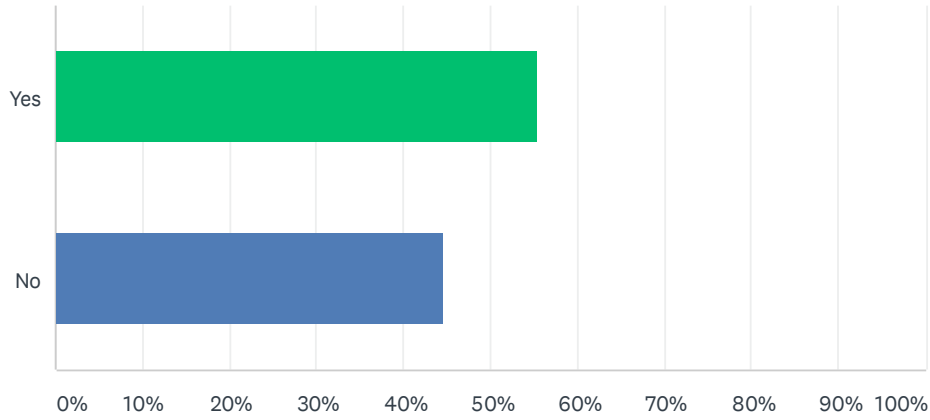
